

SHEET E1.1 [ELECTRICAL SYMBOLS AND NOTES]

1. In Abbreviations Index, add 'O.F.O.I. – OWNER FINISH, OWNER INSTALL'.

SHEET E1.2 [ELECTRICAL SCHEDULES]

- 1. EXISTING PANELBOARD 'H' SCHEDULE, CKT. #21: Utilize spare breaker and Add a new breaker with load description of "Ice Machine & Dishwasher", Amps = 20A, Pole = 1, Wire Size = #12.
- 2. LIGHTING CONTROL INTENT NARARTIVE: Under 'BOOK ROOM'/ Occupancy, reword from 'DAYLIGHT LEVEL' to 'FULL LEVEL'.

SHEET E3.1 [DEMOLITION PLANS]

- 1. View 1, BOOK ROOM 4: Disconnect and remove the existing 3-way light switch and put that on demolition layer.
- 2. View 2, BOOK ROOM 4: Move note 'D15' closer to the light fixture existing to remain.

SHEET E4.1 [LIGHTING PLAN & ELECTRICAL PLANS]

- 1. View 1, BOOK ROOM 4: Provide a new 3-way switch to the existing switch location on the east wall/side of the room. Extend wiring as required.
- 2. View 2, CONFERENCE 1: Provide a new GFCI power receptacle for UC refrigerator on east-north wall of the room and connect to nearest receptacle. Height to be coordinated with millwork shop drawings.
- 3. View 2, FACULTY ROOM 2: Provide a new GFCI power receptacle for dishwasher on west wall of the room and connect to existing panel 'H' circuit #21. Height to be coordinated with millwork shop drawings.
- 4. View 2, FACULTY ROOM 2: Provide a new GFCI power receptacle for ice machine on west wall of the room and connect to existing panel 'H' circuit #21. Height to be coordinated with millwork shop drawings.
